

Late (~10 pm EST) on Tuesday, January 21, 2025, this email was received by the Officers of SCHB, from Kevin Edgar, Chair of the ACS Committee on Nominations and Elections:

[Confidential] Communication from the Chair of the Committee on Nominations and Elections

Dear SCHB Executive Committee,

An SCHB member, who wishes to remain anonymous, requested that the Committee on Nominations review the 2024 SCHB elections for possible election violations. After careful review and consideration of the information provided, we have decided that the election will stand and requires no further investigation.

Given the concerns expressed by the member, I would like to share following recommendations for future elections:

- 1. In all future elections, SCHB shall establish a Nominations Subcommittee in compliance with their bylaws.
- 2. In all future elections, SCHB Executive Committee shall follow all of their election-related by-laws. Should they feel unable to follow one of those by-laws for whatever reason, they shall take action to suspend any election related bylaws that are not aligned with the election practices to avoid non-compliance. For example, your 6/17/2024 Executive Committee minutes reflect that action was taken to suspend SCHB Bylaw V, Section 2; however, there was no suspension of SCHB Bylaw VII, Section 2 related to the appointment of members of the standing committees. To be clear, it is good practice to appoint an independent and experienced nominations committee to put forth nominees for elected office, and poor practice for current division chairs to select such nominees themselves.
- 3. SCHB should review and amend their bylaws to accurately reflect their current election practices. (ACS Division Bylaws Page)
- 4. The SCHB bylaws are silent on the manner of elections (plurality or ranked choice). SCHB should consider clearly defining their manner of elections, so it is consistent year over year. In alignment with the Governing Documents, the Committee on Nominations and Elections recommends that ranked-choice voting be used when there are more than 2 candidates for one position.
- 5. The SCHB executive committee should review and share the ACS Volunteer & Participant Code of Conduct Policy with its division members. All ACS Volunteers are expected to adhere to the policy.

My response, sent early (1:45 am) on Wednesday, January 22, 2025:

Kevin,

SCHB bylaw V, section 4 states" The candidate for each position receiving the largest number of votes shall be declared elected."

This seems clear and does not encompass ranked voting.

With many active volunteers fleeing SCHB during the unpleasantness of 2021-22, SCHB had a thin bench. Most of our committees had but a chair, so it was with the Nom & Election committee, which I took upon myself.

It was announced early in 2024 that SCHB would allow members to self nominate, and the nomination committee only ensured that those seeking to run were eligible to do so. We had 11 people express interest, 10 who submitted the requested bio and candidate statements. 2 members decided to withdraw; so we had 8 candidates for Councilor. All 8 participated in the online Zoom candidate forum. With 137 members voting we had a turnout of 26.1%, a rate more than twice what was seen in the ACS 2024 election.

Bylaw VII section 2 states "... members of the standing committees shall be appointed annually...."

This was done.

Again we have a thin bench. As stated above the nomination chair did not rank or try to select a pair of candidates to run, but sought a field of members stepping up to run, willing to get involved. The election and high turnout, with a turnout 36% higher than the 2023 election held by the appointed EC, is proof of the wisdom of how things were done.

Updated comments to the SCHB EC:

This was good news, but...

After careful review and consideration of the information provided, we have decided that the election will stand and requires no further investigation.

Good that no further investigation is required, but....

My experience is that what happened to the SCHB is not well understood by ACS Governance, and I have no idea what information was provided. I was not contacted about this prior to Kevin's 1/21/2025 email.

Future plans:

I will make a point to talk to Kevin at the San Diego ACS meeting. In the coming day or so I will respond to Chair Kevin about our plan to address the recommendations at our February EC. Please come ready to discuss this.

We should address the recommendations in the email. #3 and #4 are the most significant, but we will directly address # 5 as well. #1 and #2 are (to my mind) non-issues, but we will discuss them at our next SCHB Executive Committee meeting on February 17, 2025.

After our February meeting, we will send a formal response to Chair Kevin about our actions, especially on the 5 recommendations, which should close the book on this incident.

NOTE: I will send out a new Zoom Invite for this meeting.
